Government/ local authority free entitlement policy

Points to consider

Parents are eligible to claim for nursery free entitlement from the term after their child turns 9 months old until they start school.

All children, from the term after they turn three, are entitled to 15 hours per week (for 38 weeks); this is known as the 'Universal Offer'. This is currently offered as five hours per half-day session for 38 weeks of the year (during term time).

Eligible working families will be able to access 30 hours of government funding per week for children aged 9 months and above, starting from the term after their child turns 9 months old, from September 2025. This will be stretched across 51 weeks of the year, so children will be entitled to a maximum of 22 hours per week.

HMRC has developed an online system that parents can use to apply for extended entitlement. If they are eligible, they will be given an eligibility code, which they will need to present to the nursery manager.

Parents will need to reconfirm their eligibility every three months via the HMRC online system; <https://childcare-support.tax.service.gov.uk/par/app/applynow>

These codes must be obtained by:

- 31st August for a 1st September start
- 31st December for a 1st January start
- 31st March for a 1st April start

It is possible for parents to claim free entitlement at two settings as long as the maximum hours that the child is entitled to are not exceeded.

To utilise the full 22 hours of extended funding at our setting, children can attend a minimum of three days per week, with hours offered as 7 hours, 8 hours, and 7 hours in that order: from 10–6pm and 11–6pm. If you choose for your child to attend full days, any hours beyond the funded allocation will be charged at our standard hourly rate.

Free entitlement policy (continued)

The table below shows how we offer funding

Funding	How it is applied	What do the parents/ carers pay?
15 hours funding, 38 weeks of the year	To benefit from the full 15 hour entitlement, the child must attend a minimum of three days per week. This will be allocated to the afternoon sessions.	The 5 hours in the afternoon are free. If the child attends the full day, the morning session will be charged.
30 hours funding, 51 weeks of the year (stretched)	To benefit from the full 30 hour entitlement, the child must attend a minimum of three days per week, 7 hours on two days and 8 hours on one day. For two day attendance, 7 hours are allocated to one day and 8 hours to the other (15 hours).	Parents will have 7 or 8 hours per day fully funded and the remaining hours, if attended, will be charged at the hourly rate. Funded hours: 10am-6pm or 11am-6pm.

If you decide to opt your child out of the extracurricular activities, they will still be fully engaged in the nursery's regular programme. If you decide not to opt your child in for meals, the cost can be covered by the nursery, and your child will receive the same hot meal as everyone else.
